## COI QUERY RESPONSE

### NIGERIA - JUDICIARY

A report released in October 2024 by *Chatham House* comments on a: “...weak and compromised judicial system that allows elites to insulate themselves from accountability.”<sup>1</sup>

In August 2024 the *Centre for Democracy and Development* includes commentary on: “...weak institutions that appear to lack the capacity to enforce accountability and transparency. Corruption, inadequate training, and poor oversight mean that abuses are not only possible but often go unchecked.”<sup>2</sup>

The *Associated Press* in August 2024 states that: “...Nigeria's...politicians ...[are] often accused of Corruption...”<sup>3</sup>

In August 2024 the *Economist Intelligence Unit* states that: “Endemic corruption is a...highly pernicious, feature of politics.”<sup>4</sup>

A report issued by *Reuters* in April 2024 states that: “Nigeria has struggled for decades with endemic corruption among senior public officials.”<sup>5</sup>

A report released in March 2024 by *Bertelsmann Stiftung* states that: “Corruption is common in the judicial system. This can work in favor of an incumbent with access to public revenues, but there have also been concerns that corruption charges are used by the executive to interfere with other powers.”<sup>6</sup>

A report issued in April 2024 by the *United States Department of State* commenting on events of 2023 notes that: “...Massive and widespread corruption affected all sectors of government, including the judiciary and security services.”<sup>7</sup>

In 2024 *Freedom House* released a report commenting on events of the preceding year which included noting that: “High-profile politicians, as well as senior law enforcement and anticorruption officials have faced corruption allegations in recent years.”<sup>8</sup>
